### DEPOSIT BONUS – TERMS AND CONDITIONS

Phyntex Group Limited is licensed in Mwali as an International Business Company (HY00823421) and as an International Brokerage and Clearing House (T2023344) under Mwali International Services Authority in Comoros Union with license number with registered address at Moheli Corporate Services Ltd, P.B. 1257 Bonovo Road, Fomboni, Comoros, KM. Phyntex Markets is a trading name of Phyntex Group Limited, hereinafter referred to as "Phyntex Markets" and/or "Company" and/or "we" and/or "our" and/or "us), "regulated and authorized by the Mwali International Services Authority. These terms and conditions (Hereinafter referred to as these 'Terms and Conditions' and/or this 'Agreement') are subject to all access and/or use of our Online Trading Facility in accordance with the terms and conditions hereof.

1. Deposit Bonus campaign (referred to as the "Promotion") is conducted by Phyntex Group Limited ("Phyntex Markets"), which is overseen by the Mwali International Services Authority (MISA).

2. The Promotion is designed as an initiation, either for

(i) potential clients from a selected region, interested in creating a live trading account with Phyntex Markets, or

(ii) existing clients who haven't yet performed a real money transaction with Phyntex Markets ("You" or "Your").

3. By engaging in the Promotion, you express consent to adhere to these Deposit Bonus terms and Phyntex Markets regular Client Agreement (including any addendums or changes), which are applicable to your account and always subject to any applicable laws (collectively referred to as the "Terms").

4. Phyntex Markets acceptance policy may render certain countries ineligible for the Promotion (termed "Selected Regions"). To qualify for the Program, you must:

4.1. Reside in one of the Selected Regions (Malaysia, Thailand, Brunei, Singapore and Philippines only)

4.2. Complete the profile verification with Phyntex Markets including uploading a Photo ID, Payment Details, and selfie verification.

- 4.3. Deposit at least the minimum required deposit (25 USD).
- 4.4. Accept and adhere to the Bonus Terms. These conditions are referred to as the "Requirements".
5. Expert Advisors (EAs) are allowed on Bonus accounts.
6. The Bonus account has identical trading conditions to the live Standard account type, with slight adjustments.
7. The Client has the option to either raise or lower the leverage on the Bonus account, up to a maximum of 1:2000.
8. The Bonus account is available in the USD currency
9. Each client may receive our 100% Bonus once per account only.
- 10.** Subject to the Client meeting all applicable requirements, Phyntex Markets shall, at its sole discretion, credit a **100% Deposit Bonus** of up to a maximum of **USD 100** to the Client's trading account upon successful deposit. This credit shall be referred to as the **"Bonus."**

(a) In addition to the above, the Company may offer the following deposit bonuses:

- **50% Deposit Bonus**, capped at **USD 300**; and
- **20% Deposit Bonus**, capped at **USD 5,000**.

(b) The 50% and 20% Deposit Bonuses shall only become available for claim after the 100% Deposit Bonus has been fully utilized or exhausted, subject to the applicable terms and conditions.

11. Phyntex Markets maintains exclusive discretion in deciding whether to award you with the Bonus. Additionally, Phyntex Markets retains the right to deny or withdraw the Bonus without any liability if it finds your participation to be in violation of any Terms or if there are suspicions of multiple accounts owned by the same client or their immediate family. Phyntex Markets reserves the right to reject a bonus request or block the Bonus account if there is a partial or complete match of IP address or other signs of the Bonus account belonging to the same person.

12. The Bonus is not withdrawable from your account. It is there to support your margin and floating only.

Any internal transfer or withdrawal from the Bonus account will result in the immediate removal of the Bonus. Additionally, the Bonus will only be credited if the client makes a

deposit directly into their Standard Bonus Account. Deposits made into wallets or any other account types are not eligible for the Bonus.

13. Phyntex Markets reserves the right to remove any Bonus credited made by mistake.

14. If there is no trading activity in your live trading account for a period exceeding 30 days, Phyntex Markets can decide to remove the Bonus completely.

15. All profits earned and transferred from the Bonus account are deemed to be null and void, if the Bonus account or live MT5 account holder has provided incorrect, false or misleading information during the registration process.

16. Phyntex Markets reserves the right to disqualify any user if there is a suspicion of misuse or abuse of fair rules.

17. Hedging trading positions internally (using other trading accounts held with Phyntex Markets) or externally (using other trading accounts held with other brokers) and thus avoiding market risk, is considered to be an abuse.

18. Using the failures in the quote flow for getting guaranteed profit or any other form of fraudulent activities are considered to be an abuse.

19. You agree to indemnify, defend and hold harmless Phyntex Markets (including its directors, officers, employees and assigns) on written demand and at all times from and against any and all liability, fines, penalties, actions, judgement, settlement, claims, demands, losses, damages, injury, compensation, costs and expenses (including interest payments, reasonable legal fees on a solicitor/client basis, other professional fees and disbursements and costs of investigation).

20. Phyntex Markets maintains the right to modify the terms of the Promotion or terminate it entirely whenever necessary. Any disputes or likely misunderstandings that may occur because of the Campaign terms will be resolved by the Phyntex Markets Management in a way that presents the fairest solution to all parties involved.

Clients agree that information provided during the registration process may be used by the Company both within the context of the Bonus account Campaign and for any other marketing purposes.
